The University is registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and has been declared fit to obtain grant from the (UGC) under Section 12-B of the UGC Act, 1956 while also being registered with the Bar Council of India (BCI).

Located in the lush green corridors of Patiala, Rajiv Gandhi National University of Law spreads over an area of 47 acres. 

#### THE RECRUITMENT PROCEDURE

The Placement Cell shall send invitations to the companies/ organisations with the relevant information. If the company/ organisation wish to conduct a Pre-Placement Talk, they can send a request along with their preferred dates for the same. The Placement Cell shall in consonance with the company/ organization's preference, allot dates for campus interviews. Companies are invited to come to the campus on the allotted date/s and conduct tests and/or interviews according to their recruitment process.

The RGNUL Placement Committee aims to streamline the placement process for both the recruiter and the participant.

We advise our students to consider each opportunity as a long term commitment and to accept offers where they can make contributions over time.
