RGNUL is located at its new state of the art campus located in Sidhuwal, Patiala. Soon after its inception in 2006, it acquired the approval of Bar Council of India (BCI) and was registered with University Grants Commission (UGC) under Section 2(f) of the University Grants Commission Act, 1956 and also received recognition under Section 12-B of the said Act. RGNUL, Punjab is a regular member of Association of Indian Universities (AIU), New Delhi and several other prestigious national as well as international institutions/organizations. It has been accredited with an A grade by NAAC.

Located in the education hub of Punjab, Rajiv Gandhi National University of Law bestows upon a rigorous and multidisciplinary legal education to the future legal professionals, scholars, judges and public servants of the country.





Campus and Library

The New Campus at Sidhuwal is a 47.30 acres sprawling campus equipped with modern technology for rain water harvesting, sewage treatment plant, solar cell panels and plantation of trees.

The Campus houses the Administrative-cum-Academic Block, a Library, an Auditorium, a Sports Complex, separate Blocks of Boys' and Girls' Hostel, a Guest House, a Community Hall, a Health Centre, Residential blocks, a Shopping Complex, Bank, Cafes, Laundry and utility services among other modern facilities. The Campus is aesthetically built keeping in mind the provision of modern amenities such as air conditioners, water coolers, etc. The entire campus is WiFi enabled and has three advanced Computer Labs. The campus is tailored to students, teachers and outsiders in a comfortable fashion. The RGNUL Library is student friendly and manned by automated software. Within a short span of time, it has managed to acquire a collection of 28,000 volumes covering a plethora of topics covering journals, text books, reports, e-books, legal periodicals, etc. The RGNUL Library currently subscribes to 94 Law Journals and Magazines. Apart from these subscriptions it also subscribes to 14 Newspapers and online journals (SCC Online, Manupatra, Westlaw, E&PW, Hein Online, JSTOR).

Evaluation and Marks

The evaluation system at RGNUL comprises of examinations, project reports, viva-voce, seminar presentations and moot courts. At the end of every semester, each student is marked out of a total of 100 for every subject.


In the first six semesters, out of the total of 100, 35 marks are for project and viva voce, 40 are for the end semester examinations, 20 are for the mid semester examinations and 5 are for class behavior and attendance.

The marking criterion is changed from the fourth year onwards to reflect the nuances of every specialization. Out of a total of 100, 80 marks are for the end semester examinations and 20 marks are for the mid semester examinations. Project Report and Moot Court is a separate paper where the project report and viva voce counts for 50 marks out of 100 and the performance in the Moot Court is the remaining 50 out of 100. The Grade Point system followed in the University is as follows:

Recruit on Campus

Video-conferencing Services

Information sessions and real time interviews can be conducted using our videoconferencing facilities, if a recruiter is unable to visit the campus. Please contact the student placement coordinators for assistance regarding scheduling and arranging for interviews/information sessions.

Placement Process and Policies

At RGNUL, we want recruiting our students to be easy and flexible. We also want to optimize your success and deliver highest yield possible based on your offers and marketing efforts. With this in mind, we have outlined a set of guidelines practised by organizations that tend to have the highest acceptance rate.

Unless explicit permission has been provided by the Placement Committee, participants are restricted from approaching potential recruiters directly for individual placements. Companies are requested to interact either through student placement coordinators or executives of the Placement Committee.

Campus Visit Policy

Potential recruiters may visit the University before the scheduled placement days to conduct interactive sessions and discussions.

Following guidelines shall be applicable in this context:

Any on-campus activity which is not a part of regular academic curriculum is defined as recruiter-participant interaction. We actively encourage all potential recruiters to visit the campus for a live interactive session with their potential employees.

All campus activities must be scheduled in conjunction with the RGNUL Placement Committee.

Communication

The RGNUL Placement Committee aims to streamline the placement process for both the recruiter and the participant.

We advise our students to consider each opportunity as a long term commitment and to accept offers where they can make contributions over time. The placement committee understands your need to finalize business planning and encourage students to make their decisions as quickly as possible. We encourage you to stay in close contact with the RGNUL Placement Committee throughout the recruiting season and offer process so that we can ensure students are adhering to our guidelines and assisting you with any helpful information.
