It was unanimously decided that in view of guidelines for disposal of vehicle, following procedure is required to be adopted for disposing of the old vehicles of RGNUL:

- 1. Open auction by giving notice of 21 days clear notice for publication in press (newspaper).
  - 2. Detailed auction notice depicting following conditions for putting on website of RGNUL.
  - 3. If no bid is received as per above or equivalent to the reserve price in first auction, then vehicle can be sold on reserve price on first come first basis within next 15 days to any person belonging to the following categories:

"Government servants retired Government Servant, Ex MP/Ex MLA, War Widows, MP/MPLAs"

All these categories will carry same level of priority

The vehicle can be inspected in University campus from 10.00 AM to 4.00 PM on any working day.

Refundable security of Rs. 10,000/- shall be deposited by the participant for giving offer before start of auction.

The purchaser will not be given benefit of No claim bonus of Insurance.

The successful bidder shall deposit 25% amount of auction money by adjusting security of Rs. 10,000/- immediately otherwise his security amount of Rs. 10,000/- shall be forfeited.

The balance 75% amount shall be deposited within 7 days and the vehicle shall be

handed over on receipt of full amount.
