



## CALL FOR APPLICATIONS – INTERNS (FULL TIME/PART TIME)

### ABOUT CCV:

The Centre for Criminology, Criminal Justice and Victimology at Rajiv Gandhi National University of Law, Patiala has been set up with the objective of promoting research, training, policy analysis and consultancy in the field of Criminal Justice, Criminal Law, Criminology and Victimology.

### POSITION:

The Centre is looking to engage full/part time interns to assist with an ongoing research project titled “Status of Radicalization in India: An Exploratory Study of Prevention and Remedies” and other activities of the Centre at Rajiv Gandhi National University of Law, Patiala.

### ABOUT THE PROJECT:

The project seeks to analyse and evaluate the phenomenon of radicalisation in India and suggest practicable solutions to effectively remedy and/or prevent the problem. The need for this study is of particular pertinence to policy-makers and law enforcement agencies in India, both of whom are moving away from a security centric approach exemplified by strengthening of the intelligence apparatus and brute force counter-terrorism/counter- insurgency operations towards a more permanent solution-based approach. This study seeks to assist the agencies of the state in this direction.

The project is sponsored by the Bureau of Police Research and Development (BPRD), Ministry of Home Affairs (MHA), Government of India.

### DURATION:

The applicants are required to mention the duration of their availability at the time of application itself. Minimum duration is four weeks. Preference shall be given to applicants who are available from 17<sup>th</sup> January, 2022 and can be engaged for longer duration if required.

**RESPONSIBILITY:**

1. The interns shall primarily be required to conduct research for the above said project and assist in the areas of Criminal Justice, Criminal Law, Criminology and Victimology under the supervision and guidance of Research Associates/Assistants of the Centre.
2. The interns shall also be expected to be involved with other activities of the Centre including the organisation of seminars, conferences, workshops and symposiums.

**CRITERIA FOR SELECTION:**

1. CGPA/Percentage.
2. Publication
3. Previous internships
4. Preference will be given to the students who have completed two years of the five-year integrated LL.B. Programme/ two years of a three year LL.B. Programme.
5. Preference will be given to candidates residing in Patiala.

**APPLICATION PROCESS:**

The applicants are required to submit their CVs and a Statement of Purpose (maximum 400 words) to [ccv@rgnul.ac.in](mailto:ccv@rgnul.ac.in) mentioning the period of internship for which they are available. The interns shall be informed of their selection via email.
