Participants availing Institutional Registration shall be eligible for only 2 offline activities

### For 2 participants of an Institute:

**Online Mode:** The participant shall enter NA for the fields not required. Do not use special characters while filing the form.

The participant shall enter name of the first student in the list and fill Rs. 1000/- as Institutional Registration fees.

The name of other participants must be mentioned in Remarks Section of the form. In case the group from an Institute is availing accommodation, the student shall fill an amount of Rs. 2000/- (for two students Registration + Accommodation charges)

### For group of 4 Participants of an Institute:

**Online Mode:** The participant shall enter the name of the first student in the list and fill Rs. 1000/- as Institutional Registration fees

In case group of 4 is availing accommodation the student must fill Rs.2000/- (500x4) as the accommodation charges; total fee for 4 participants availing accommodation is Rs. 3000/- (1000+2000)

The scanned copies of the Institutional Registration Form, Institutional ID and e-receipt/DD must be mailed to [expressions@rgnul.ac.in](mailto:expressions@rgnul.ac.in) before 14<sup>th</sup> March 2017.

The hard copies of the same must reach, on the address mentioned in the brochure, on or before 15<sup>th</sup> March 2017.

The name of other three participants must be mentioned in Remarks Section of the form.
