#### ABOUT PUNJAB STATE LEGAL SERVICES AUTHORITY

The Legal Services Authority Act, 1987 came into force throughout the country w.e.f. 09.11.1995. Thereafter the Punjab Government constituted Punjab Legal Services Authority which came into being on 04.10.1996. Hon'ble Chief Justice of Punjab & Haryana High Court is the Patron-in-Chief while the Hon'ble Judge is Executive Chairman of this Authority. Judicial officer of the rank of District Judge is the Member Secretary of the Authority. At each district and sub-divisional level, District Legal Services Authority as well as Sub-divisional Legal Services Committees have been constituted. District and Sessions Judge is the Chairman of District Legal Services Authority whereas Additional Civil Judge (Senior Division) is the Chairman of Sub-Divisional Legal Services Committee. The Legal Services Authorities Act, 1987 aims at providing free and competent legal services to the weaker section of the society with a view to ensure that opportunities for securing justice are not denied to any citizen by reason of economic or any other disability. Punjab State Legal Services Authority aims to provide legal assistance, strengthening the team of Para-Legal volunteers, encourage ADR methods etc. for the State of Punjab.

## ABOUT RAJIV GANDHI NATIONAL UNIVERSITY OF LAW, PUNJAB

Rajiv Gandhi National University of Law (RGNUL) Punjab, was established by the State Legislature of Punjab by passing the *Rajiv Gandhi National University of Law*, *Punjab Act*, (Punjab Act No. 12 of 2006).
