About MBA (Law) at RGNUL

Take a leap towards the next stage of your career with our novel and distinct MBA (Law) course that has been diligently designed for the young aspirants aiming a place in the corporate world. Keeping in line with the dynamics of the contemporary requirements of education and employability in diverse fields, we are expanding our horizon by introducing an MBA (Law) program, whereby the focus can be laid on sensitizing the graduates with the intricacies of business administration and law, so that they can serve a dual purpose of a business administrator as well as a legal advisor to a corporate entity. It will be interesting to equip the aspiring graduates with the theoretical and practical dimensions of the integrated knowledge of Management and Law, through our course.

The two-year MBA (Law) course is a distinctive program for the young and creative minds who understand the power of doing things differently. This program is for students who wish to gain expertise in both, legal and management practices. It aims to equip the students with the tools to understand legalities from the perspective of a businessman and to understand business from the perspective of a lawyer. TEACHING PEDAGOGY

ABOUT RGNUL

RGNUL is a national law institution of eminence which aims to inculcate amongst the students an aptitude towards learning and skill acquisition and with this objective, we teach law in the form of B.A.LL.B (Hons.) FYIC and LL.M. (One year program) Along with these, we also offer PhD degree in Law and Social Sciences in integration with Law.

Rajiv Gandhi National University of Law, Punjab (RGNUL) has been established by the State Legislature of Punjab by passing the Rajiv Gandhi National University of Law Punjab Act, 2006 (Punjab Act No. 12 of 2006). RGNUL campus is situated at Sidhuwal, Bhadson Road, Patiala (Punjab) which is about 70 km from Chandigarh.

The University acquired approval of the Bar Council of India (BCI) in August 2006. The University got registered with the University Grants Commission (UGC), New Delhi under Section 2(f) of the University Grants Commission Act, 1956 and also got recognition under Section 12-B of the UGC Act. RGNUL is a regular member of Association of Indian Universities (AIU), New Delhi and several other prestigious National and International institutions.

RGNUL is the first National Law University which has been awarded 'A' Grade by National Assessment and Accreditation Council (NAAC) after rigorous assessment based on various quality parameters. RGNUL has also been accorded Graded Autonomy under the UGC (Categorisation of Universities (only) for Grant of Graded Autonomy) Regulations, 2018. RGNUL received a major boost for its performance by being placed in the top 10 law universities in the NIRF rankings in 2018-19 and 2019-20. In Swachh Campus Rankings 2019 RGNUL has been adjudged at First Rank (Cleanest) in the Country among Government Residential Universities by MHRD.
